

# Town of Port Deposit Town Council Meeting Minutes Work Session Meeting Conference/Video Meeting April 16, 2024

# **CALL TO ORDER**

## **NEW BUSINESS**

Casella Waste Systems Addendum – Town Administrator Rinkerman presented an addendum to the town's contract with Casella Waste Systems, to include the addition of Newport Landing trash service to be added to the town's contract effective July 2024 and billing to be done through individual property taxes.

Motion made by Councilwoman Thiele to approve the addendum as presented. Seconded by Councilman Knight. Roll call vote: Thiele – Y, Knight- Y, Berlin- Y. Motion carried unanimously.

Security for Town Hall building — Public Works Director Jamison gauged the Council's interest in the installation of a security system for the Town Hall entrance. This would potentially include a buzz-in system with video in addition to key fobs for authorized staff and officials. Council directed Jamison to proceed with obtaining estimates.

Public Works Director Jamison also inquired about considering the installation of a back door into Town Hall as an emergency exit. Council recommended looking at various options to include a flip step and what might be recommended for the building. Council directed Jamison to proceed with obtaining estimates.
